Heritage Brook Homeowners Association Parking Restriction Covenant:

Vehicles shall be parked only in garages or driveways with the following exception:

Service or delivery vehicles may be parked on the street or in front of the home they are servicing while work is being performed for a period of six hours or less.

Vehicles violating this restriction are subject to fine or towing at the owners expense.

For any extenuating circumstances or special occasions that require short term street parking, homeowner is required to contact and clear their short term request with HOA management.

This covenant is established to support and maintain the visual integrity of our community, which improves resale value, and to provide unhindered access to homeowners and emergency"

 - ➤ Huntsville City:
 - Paving of Heritage Brook:

- Only 3 Paving contractors in North Alabama
- We are on the waiting list.
- Legacy is paying for the fix.
- Roundabout: repaired again
- Railing: haven't heard back from the city. Will request an update.
- Sidewalk on both sides of street fixed near sinkhole
- Google Fiber installed on south side, so the road is sliced and they are coming back to fill the road and repair the curb.

> Financials

- April so far \$600 going out, with revenue due to more HOA fees
- March expenses was \$3,900, \$3,000 for tree service
- February was \$800

Delinquencies

- Faith and Crystal from Elite met with the lawyer
- Crystal sent out letter stating that the next step was hearing from our lawyer
- Liens are placed on properties if the HOA dues are delinquent
- If not paid, they can place a judgment against you.
- Homeowner would be responsible for all fees incurred in the lien process.
- ➤ Update email list with new homeowners

Open Floor to Neighbors

- ➤ Parking issue
 - Board made amendments to the covenants and it was filed in the courts.
 - The problem with loosening it, it will become harder to enforce.
 - Other neighbors have not been able to get in and out of their driveways due to people parking in the street.
 - Board responded that a courtesy email to Elite and the HOA email about an event that required street parking would not result in a violation.
 - Board responded that the school bus will not travel down Heritage Brook to the Hollybrook Bus Stop if there are cars parked on Heritage. We will procur this information in writing.

- ➤ Neighbors car was parked in front of their house and they were sent a warning letter. Faith will call Kelly about the homeowners warning letter.
- Amendments: only the board needs to vote, but we do talk to the community first.
- ➤ Other neighbor believes we don't have the right to tow a car on a public street.
 - Faith talked to the lawyer and she said that it was ok for us to tow because of our covenants and bylaws.
 - Faith will talk to a lawyer for clarification and
- ➤ Concerned about Elite's oversight. Board told them what they actually do for us pay our bills, enforce bylaws and covenants, collect HOA dues.
- Fences painted wrong and trash can in the front of houses is not a high priority. Board responded that the safety of the homeowners and children were more important
- In regard to nominations and voting, they think there should be descriptions about the nominees. Next year we will include those.

 - Railing completed but concerned about the tree
 - Sidewall is caving in.
 - Emailed Cit but hadvnt heard back.
- Sprinklers need to be winterized
 - Estess Irrigation recommended by Elite and they did the job last year.
 - Sprinklers are off.
 - Vote to have Estess Irrigation to winterize the sprinklers.

 - Second: Linda Lowe

- Lawncare 2020 (Current contract runs out at end of December)
 - o Alabama Lawn Enforcement bid was same as 2019.
 - Vote
 - Motion: Kyle motions to go with Lawn Enforcement.
 - Second: Linda
 - All in Favor
- Treasurer's Update (Linda)
 - October spent \$2100 for a property tax bill
 - November only \$114
 - o Postage is high due to an increase in violations
 - o In December, liability insurance will be paid out.
 - Dues will start being paid in December.
 - Estimating about \$26,000 in total years expense
 - o Approximately \$24,000 in surplus.
 - Delinquencies are over \$4000
 - Liens on several homes. If those homes don't pay, they will be taken to court.
 - o For the homes being sold that have liens, the fees will be paid during escrow.
 - Liens are on homes that have not paid.
 - Those that are not paying liens will be taken to court to recover the money owed
 - A home in escrow has a lien on it. We should get paid
- Lot next to wooded lot (Common Area F)
 - Looking to grade and sod/seed in Spring 2020
 - Get more quotes in February/March
 - Fertilizing the front area
- Send any ideas for common area F to heritagebrookhoa@gmail.com
 - Common Area F grade, sod and seed
 - Knoll flatter and maybe some light landscaping, possibly a gazebo
 - o Roundabout has a water meter but no sprinklers.
- Neighborhood Mapping
